STATUS

Association under the law of 1 July 1901 and the decree of 16 August 1901

E.C.S.E.

ARTICLE 1 - NAME

An association governed by the law of 1 July 1901 and the decree of 16 August 1901 is founded between the members of the present statutes, with the title "Eco-Citizen Solidarity Entrepreneurship", acronym: E.C.S.E.

ARTICLE 2 - AIM/OBJECTIVE

Within the framework of an Erasmus project with students, the purpose of this association is to enable the marketing of products, the profits of which will be donated in full to charity.

ARTICLE 3 - REGISTERED OFFICE

The registered office is located at: Lycée SAINTE LOUISE DE MARILLAC - 68 avenue Victor Dalbiez - 66000 PERPIGNAN

It may be transferred by simple decision of the board.

ARTICLE 4 - DURATION

The duration of the association will be the time it takes to carry out the project, i.e. two school years, from 01/09/2021 to 15/07/2023.

The Board may decide to extend the duration at a later date.

ARTICLE 5 - COMPOSITION OF THE BUREAU

The association is composed of natural persons:

ARTICLE 6 - ADMISSION

In order to be a member of the Association, it is necessary to be approved by the Bureau, which shall decide on the applications for admission at each of its meetings.

ARTICLE 7 - MEMBERSHIP - FEES

The present association does not require any membership fee from its members.

ARTICLE 8 - TERMINATION OF MEMBERSHIP

Membership is lost by:

- Resignation
- Death

ARTICLE 9 - AFFILIATION

The present association is affiliated to the association of the SAINTE LOUISE DE MARILLAC high school "Learning through projects" which will take charge of the project transactions on its bank account and will cover the members by its insurance.

ARTICLE 10 - RESOURCES

The association's resources come from the Erasmus budget allocated for the project.

ARTICLE 11 - ORDINARY GENERAL ASSEMBLY

It shall meet once a year and shall automatically include all the members of the Bureau and possibly certain honorary members.

The members will be informed 15 days before the date and convened by the secretary.

The president, assisted by the other members, chairs the meeting and reports on the activities of the association.

The treasurer reports on his management and submits the accounts for approval by the assembly.

Decisions are taken by a majority of votes of the members present or represented.

ARTICLE 12 - EXTRAORDINARY GENERAL MEETING

If necessary, or at the request of half plus one of the registered members, the President may convene an Extraordinary General Meeting.

The procedures for convening a meeting are the same as for the ordinary general meeting. Decisions are taken by a majority of votes of the members present or represented.

ARTICLE 13 - ALLOWANCES

All functions, including those of the members of the Bureau, are free and voluntary. Only expenses incurred in the performance of their duties shall be reimbursed on the basis of receipts.

ARTICLE 14 - DISSOLUTION

In the event of dissolution pronounced in accordance with the terms of Article 12, one or more liquidators shall be appointed, and the net assets, if any, shall be vested in a non-profit organisation, in accordance with the decisions of the Extraordinary General Meeting which decides on the dissolution. The net assets may not be transferred to a member of the association, even partially.
